GENERAL RULES

These rules have been adopted with the enjoyment and safety of all members and their horses in mind.

- 1. LIABILITY** All members must have a signed RELEASE AND WAIVER OF LIABILITY AGREEMENT in order to use the facilities.
- 2. MEMBERS** Pillsbury Ranch Riding Club is a member only facility. A member shall be an individual or family that owns or leases their own horse or horses. Trainers working horses other than their own are not allowed without prior written consent and agreed arrangement with Club management.
- 3. GUEST RIDERS** ABSOLUTELY NO GUEST RIDERS WILL BE ALLOWED ON THE PREMISES
- 4. VEHICLES/TRAILERS** All vehicles and trailers are to be parked in designated parking areas at all times with parking permit clearly visible. Please do not park along the sides of driveways or arenas.
- 5. CHILDREN** Children shall be under parental supervision at all times.
- 6. DOGS** Dogs are to be on a leash at all times.
- 7. HORSES** Horses are never to be left unattended while on the facility.
- 8. TYING OF HORSES** Horses are not to be tied to pipe panels or trees at any time. Tie racks or trailers attached to vehicles are to be used for tying horses.
- 9. RIDER PRIORITY** Riders have priority in all arenas.
- 10. TURN OUTS** Round pens are available for turn outs and lunging . ABSOLUTELY NO TURN OUTS OR LUNGING IN RIDING ARENAS. TURNED OUT HORSES MUST BE ATTENDED BY AN OWNER.
- 11. DRIVING** All driving horses shall give way to riders and stop if necessary until riders are in full control of their horses. Drivers should be aware at all times of ridden horses in close proximity and use due caution when proceeding.
- 12. ARENA USE** The main arena, round pens and perimeter track are available for use by all members. Priority use of the cutting, roping and dressage arena as well as the driving/reining arena is given to those members practicing these events or taking lessons by a trainer in these events.
- 13. WASH RACKS** Horses are not to be left to dry on wash racks. Please tie on the available tie racks to trailers attached to vehicles. Please clean up after your horses and hang hoses neatly.
- 14. STANDING HOLES** Members are to refill any holes made by horses pawing while tied to posts or trailers.
- 15. TRASH** Please place all trash in the provided containers.

16. DAMAGES/BROKEN EQUIPMENT Please report any damages to any facility equipment immediately so we can make necessary repairs.

17. SPEED LIMIT The speed limit on the facility is limited to 5mph (Five miles per hour).

18. MEMBERSHIP CARDS/PARKING PASSES All members must have valid membership cards in visible location (such as tied to saddle, belt, etc) at all times while using facility. Parking passes must be placed in a visible location on dash. Cards and parking passes are not transferrable.

19. GATE CLOSURE If you are the last person leaving the facility, it is your responsibility to ensure all gates are closed.

20. TRAINERS Trainers working horses other than their own are explicitly not allowed without prior written arrangement and contract with Club management.

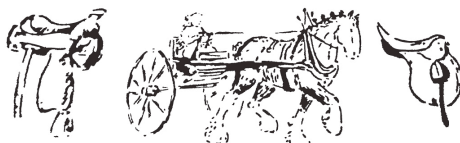

ARENA RULES

DRESSAGE ARENA

This arena is designed to be used by riders practicing the discipline of dressage

GENERAL USE ARENAS

1. ABSOLUTELY NO TURNOUTS PERMITTED IN THESE ARENAS
2. PLEASE DO NOT LUNGE HORSES IN THESE ARENAS

ROUND PENS

1. Turnout is permitted WITH OWNER IN ATTENDANCE ONLY.
2. You may lunge your horse in these pens.
3. Please be considerate of others waiting to use the round pens and only occupy these pens for a reasonable period of time.

PERIMETER TRACK*

1. ABSOLUTELY NO RACING IS ALLOWED. This track is to be used for exercising horses and horses must be under the rider's control at all times.

*Please do not gallop horses by the dressage arena while it is in use by other members.





HISTORY OF THE CLUB

Pillsbury Ranch Riding Club (also known as The Lakeside Saddle & Driving Club), was established in 1981 by Duane and Joan Embery Pillsbury because of the need for a community equine facility in the Lakeside area. The facility was planned and developed to accommodate all types of equine activities including roping, dressage, cutting, driving, eventing and reining.

Currently, the facility has a dressage arena, three general use arenas, a large round pen and two lunging round pens. The perimeter track is approximately one mile and has excellent footing, as do all of the arenas. A driving and reining area is set aside which has the harder surface needed for these activities. In addition to the arenas, the facility has two wash racks, a restroom facility and picnic areas complete with tables and benches for use by club Members.

Pillsbury Ranch Riding Club plans to continue to improve the facility to meet the needs and enjoyment of its members and the equine community. The desire to make Pillsbury Ranch Riding Club one of the finest equine facilities in Southern California continues to be our goal.

Individual and family memberships are available in the Pillsbury Ranch Riding Club. Annual membership dues help defray the costs of maintaining the facilities and equipment and have been kept as low as possible.
